All schools within the Berlesduna Trust have a similar approach to meeting the needs of pupils with Special Educational Needs and are supported by the Local Authority to ensure that all pupils, regardless of their specific needs, make the best possible progress in school. All schools are supported to be as inclusive as possible, with the needs of pupils with a Special Educational Need/s and or disabilities being met in a mainstream setting wherever possible, where families want this to happen.

The SEN Code of Practice (January 2015) sets out in Chapter 6.15 that:

'A pupil has SEN where their learning difficulty or disability calls for special educational provision, namely provision **different from** or **additional to** that normally available to pupils of the same age.'

We have set out below who will provide this different/additional provision and also how and what we will provide your child/children with Special Educational Need or Disability.

<p>How can I talk to them about my child if I need to?</p> <p>What are the policies for identifying children and young people with SEN and assessing their needs, including the name and contact details of the SENCO?</p>	<p>Special Educational Needs Co-Ordinator (SENCO)</p> <p>Mrs Walker</p> <p>Learning Support & Welfare Assistant (LSWA) may be allocated to some pupils with SEN and or disabilities)</p> <p>Class Teacher</p>	<ul style="list-style-type: none"> • Checking on the progress of your child and identifying, planning and delivering any additional help your child may need (this could be things like targeted work, additional support, adapting resources etc..) and discussing amendments with the SENCO as necessary • SEN Support pupil: discuss targets and steps in a One Plan - For pupils receiving SEN support, One Plans will be jointly written by the SENCO and the class teacher. However, the class teacher will be responsible for leading the termly One Plan meetings with parents and carers, as they have the most regular contact with the child and oversee day-to-day provision. • EHCP pupil: a more formalised One Planning Meeting will be held to discuss the child's needs in greater detail and plan for the future. We ensure that all members of staff working with your child are aware of your child's individual needs and/or conditions and what specific adjustments need to be made to enable them to be included and make progress. • Ensuring that all staff working with your child in school are supported in delivering the planned work/programme for your child, so they can achieve the best possible progress. This may involve the use of additional adults, outside specialist help and specially planned work and resources. • Ensuring that the school's SEND Policy is followed in their classroom and for all the pupils they teach with any SEND. • Your child's teacher will be available to speak to at the end of the school day or by appointment as necessary. <p>Ms Walker is responsible for:</p> <ul style="list-style-type: none"> • Coordinating the support for children with special educational needs (SEN) and or disabilities, and developing the school's SEN Policy to make sure all children get a consistent, high quality response to meeting their needs in school. <p>They will ensure that as parents/carers you are;</p> <ul style="list-style-type: none"> ○ Fully involved in supporting your child's learning ○ Kept informed about the support your child is getting ➤ Involved in reviewing how they are doing ○ An integral part of planning ahead for them. <ul style="list-style-type: none"> • Liaising with all the other people who may be coming into school to help support your child's learning e.g. Speech and Language Therapy, Educational Psychology etc. • Updating the school's SEN records and making sure that there are up to date details of your child's progress and needs.

- Providing specialist support for teachers and support staff in the school so they can help your child (and other pupils with SEN and/or disabilities in the school) to achieve their potential
- Supporting your child's class teacher to write learning targets for your child to achieve
- Organising training for staff so they are aware and confident about how to meet the needs of your child and others within our school
- Arranging and carrying out One Plan meeting with parents, children, staff and relevant professionals in order to audit and review the current provision for your child and decide on new targets for the future

The SEN COP sets out what the key responsibilities of the SENCO may include:

- overseeing the day-to-day operation of the school's SEN policy
- co-ordinating provision for children with SEN
- liaising with the relevant Designated Teacher where a looked after pupil has SEN
- advising on the graduated approach to providing SEN support
- advising on the deployment of the school's delegated budget and other resources to meet pupils' needs effectively
- liaising with parents of pupils with SEN
- liaising with early years providers, other schools, educational psychologists, health and social care professionals, and independent or voluntary bodies
- being a key point of contact with external agencies, especially the local authority and its support services
- liaising with potential next providers of education to ensure a pupil and their parents are informed about options and a smooth transition is planned
- working with the Headteacher and school governors to ensure that to ensure that the school meets its responsibilities under the Equality Act (2010) with regard to reasonable adjustments and access arrangements
- ensuring that the school keeps the records of all pupils with SEN up to date

A Learning Support & Welfare Assistant (LSWA) may be allocated to a pupil or group of pupils with exceptional special educational needs and/or disabilities and whilst they take a very valuable role in a child's education, we would prefer that questions regarding your child's learning and progress are directed to the staff members named above. Of course, as a school we welcome daily dialogue between

parents and LSWAs on how a child's day has been and we do actively encourage this continued feedback!

Ms Walker (SENCO/HT) is responsible for:

- The day to day management of all aspects of the school, this includes the support for children with SEN and/or disabilities
- As SENCO she will give responsibility to class/subject teachers but is still responsible for ensuring that your child's needs are met
- She must make sure that the Governing Body is kept up to date about any issues in the school relating to SEND

The SEND Governor is responsible for:

- Making sure that the school has an up to date SEND Policy
- Making sure that the school has appropriate provision and has made necessary adaptations to meet the needs of all children in the school
- Making sure that the necessary support is made for any child who attends the school who has SEN and/or disabilities

Making visits to understand and monitor the support given to children with SEND in the school and being part of the process to ensure your child achieves his/her potential in school.

<p>How are parents/carers consulted about their children with Special Educational Needs and how does the school involve parents in their child's education?</p>	<ul style="list-style-type: none"> • If the school has a concern regarding your child, we will contact you and ask you to come in and meet with the Class Teacher and/or the SENCO. We will share with you our concerns and ask you to let us know if you have any concerns. • If we feel your child needs to be added to our list of children with Special Educational Needs, we will let you know. • If we feel it is necessary, we will hold a One Planning meeting to discuss your child's needs and set appropriate targets. Depending on the level of need it may be that a One Planning meeting is not required and instead a One Page Profile will be written which will include lots of information about your child, their needs, strategies that may support their learning and targets to work towards. • If we feel that your child could benefit from being seen by a professional in the community such as a Community Paediatrician, Speech and Language Therapist, Occupational Therapist etc the SENCO will be happy to meet with you to obtain your views and share the views of the school. She will then write a referral to the Children's Single Point of Access (CSPA) to request their services. <ul style="list-style-type: none"> • As parents, we welcome your involvement in every stage of your child's education and look to you to help us to 'assess, plan, review and do' what needs to be done to help your child to reach their potential. • We will seek your permission to obtain any assistance from external specialists if we deem it necessary. • When specialist teachers or external agencies come in to work with your child, we will let you know what has happened. Sometimes the professionals want to meet with you so the SENCO will arrange for you to be present also. If you are not present, we will forward to you any reports that we receive. • If it is felt your child may need an Education Health and Care plan (EHCP), we will work with you and attend meeting and support you and complete all the necessary paperwork to obtain it. This will also involve having One Planning meetings in order to generate the paperwork needed to request the EHC Plan. • If your child has an EHC Plan we will hold an annual review meeting in the form of a One Planning Meeting which you will be invited to. At this meeting you will meet with all the adults working with your child and you will be asked to give us your views on all aspects of your child's education. We will also set new targets for the coming year.
<p>How are children and young people with SEN consulted and involved in their own education?</p>	<ul style="list-style-type: none"> • When a child or young person is identified as having a Special Educational Need and they have a One Page Profile or One Planning paperwork, their teacher will talk with them about their targets and offer the correct support and strategies to enable them to achieve them. • Children are encouraged to give their views as to their education particularly when there is a need to obtain an EHC Plan.

	<ul style="list-style-type: none"> • Children are encouraged to attend their Annual Review/One Plan meetings and to give their opinions and ideas. • As a school we fully involve all children in their own education.
<p>What are the different kinds of Special Educational Needs that the school provides for?</p>	<ul style="list-style-type: none"> • St Mary's C of E Primary School welcome all children with a wide range of special educational needs and disabilities including children who are looked after and have special educational needs and or disabilities. These include all children with difficulties in cognition and learning, sensory or physical difficulties, communication and language and Social Emotional and Mental Health. We make reasonable adjustments, including the provision of auxiliary aids and services for children with special educational needs and or disabilities. We provide the necessary support for children with medical needs and will follow care plans for these children to ensure we provide the appropriate care. • St Mary's C of E Primary School ensures that children who have SEND and are looked after and those in receipt of Pupil Premium are provided with the appropriate support that enables them to achieve their potential.

<p>What are the different approaches used to teach children and you people with SEN and /or disabilities at St Mary's C of E Primary School?</p>	<p>Class teacher input through high quality, good and or outstanding classroom teaching and differentiation.</p>	<p>The teacher will have the highest possible expectations for your child and all pupils in their class. All teaching is based on building on what your child already knows, can do and can understand. Putting in place different ways of teaching so that your child is fully involved in learning in class. This may involve things like using more practical learning or providing different resources adapted for your child. Teaching is differentiated according to ability and support deployed as necessary to meet the needs of the learners. We may discuss putting in place specific strategies (which may be suggested by the SENCO or from outside agencies) to enable your child to access the learning task.</p>	<p>All children in school receive this.</p>
<p>How are adaptations made to the curriculum and the learning environment of children and young people with SEN?</p>	<p>Specific small group work/ intervention groups</p>	<p>Your child's teacher will have carefully checked your child's progress and will have decided that your child has gaps in their understanding/learning and needs some extra support to close the gap between your child and their peers.</p> <p>He/ She will plan group sessions for your child with targets to help your child to make more progress.</p> <p>Within class or outside of class a LSWA or teacher will teach these small group sessions using the teacher's plans, or a recommended programme.</p> <p><u>The resources we would access may include:</u> Numicon/visual resources to support the understanding of mathematical concepts, social story/skills programme, additional phonics teaching, additional reading programmes, speech and language boosters such as Talk Boost, fluid groups/interventions to support day to day learning that may not have been understood.</p>	<p>Any child who has specific gaps in their understanding of a subject/ area of learning.</p> <p>Some of the children accessing intervention groups may be at the stage where they have been identified by the class teacher as needing some extra support in school. Their LSA may rephrase and assist then during lesson inputs to ensure they fully understand the learning. They may then work within small groups on activities differentiated according to their need. There are some occasions when the children may have interventions outside of the classroom on a 11/small group basis as part of the requirements of their EHCP. 	<p>All children</p>

<p>What support does the school offer for improving emotional and social development?</p>	<p>Whole Class Activities</p> <p>Small Group</p> <p>1 To 1 support</p> <p>Enlisting support from external services such as Kids Inspire</p>	<p>St Mary's C of E Primary School prides itself on the level of support we offer our students in support of their emotional and social development and very often any resulting behaviours.</p> <p>The SENCO and class teachers, work with children and their families to offer support and guidance to help children cope with any situations that may be causing them distress.</p> <p>PSHE sessions are delivered weekly and our mapped to our curriculum so that all children have an opportunity to discuss emotional and social issues.</p> <p>When necessary, we may suggest your child would benefit from seeing a counsellor via Kids Inspire. If we feel the need, or families request this, we may refer the children to The Emotional Wellbeing and Mental Health Service (EWMHS) for help and support. When the emotional and social difficulties begin to affect the child's behaviour and learning we may request that you allow us to refer your children to the Educational Psychologist attached to our school or our SEND Inclusion Partner for further support. In the most severe cases we may need to apply for an EHCP if your child's social and emotional needs are causing a significant barrier to their learning.</p>	<p>All children receive support for their social and emotional needs.</p> <p>Support at a higher level is given for those whose SEMH needs are affecting their learning and development.</p>

<p>How is the expertise and training of staff to support children and young people with SEN, including how specialist expertise will be secured, managed and delivered?</p>	<p>Teacher Training</p> <p>Training from external agencies</p> <p>SENCO</p> <p>Berlesduna Academy Trust Training</p> <p>Outside agency involvement.</p> <p>This may be from:</p> <ul style="list-style-type: none"> • Local Authority central services such as Visual support or Hearing Impaired • Outside agencies such as the Speech and Language 	<p>Ms Walker is the Headteacher and SENCO who has obtained the National Award for SEN CoOrdination qualification. Previous to her appointment at St Mary's, she worked in a mainstream school which hosted an Enhanced Provision for pupils with an EHCP for Speech, Language and Communication Needs. She holds her ELKAN accreditation for SLCN. She holds a specialist accreditation in supporting pupils with Social, Emotional, and Mental Health (SEMH) needs.</p> <p>All staff are trained to work with children with a range of SEND. All teachers can appropriately differentiate the learning activities to ensure all children can access the learning and achieve their potential. If a child enters the school with a particular learning need that needs further training, then we seek the support of outside agencies to assist with that training. Appropriate staff will then be trained to cater for a particular child's needs. When a child has an identified special educational need the support received from external agencies such as specialist teachers will be requested and staff will work under the direction of those professionals to ensure they are fully catering for the needs of the child.</p> <p>The SENCO provides guidance and training for staff working with children with SEN. If your child has been identified as needing more specialist input, instead of, or in addition to good and outstanding classroom teaching and intervention groups, referrals will be made to outside agencies to advise and support the school in enabling your child to make progress.</p> <p>Before referrals are made, we will discuss your child's progress with you and together we will plan possible ways forward. If it is agreed that the support of an outside agency is a way forward, you will be asked to give your permission for the school to refer your child to a specialist professional e.g. a Speech and Language Therapist or Educational Psychologist, Community Paediatrician. This will help the school and yourself understand your child's particular needs better. Ms Walker is able to make these referrals with your permission. <p>How will we support your child with identified special needs before and when they start at our school?</p>	<ul style="list-style-type: none"> • We will invite you to visit the school with your child to have a look around and speak to staff • Staff from school will visit or speak with the pre-school setting. 	<ul style="list-style-type: none"> • If other professionals are involved, we will try to meet them or contact them to discuss your child's needs, share strategies, and ensure provision is put in place before your child starts. • Depending on your child's needs we may suggest transition visits or adaptations to the settling in period to help your child to settle more easily. This could include beginning on a part time basis with a clear idea as to when and how this will be increased to ensure your child is in school full time as soon as possible. • If your child is to have a key person involved, we will endeavour to arrange times when they can meet you and your child to get to know each other. 	
<p>What are the arrangements for supporting children and young people in moving between phases of education and in preparing them for adulthood?</p>	<p>We recognise that 'moving on' can be difficult for a child with SEN/and or disabilities and take steps to ensure that any transition is as smooth as possible.</p> <p><u>If your child is moving to another school:</u> We will contact the new school's SENCO and ensure he/she knows about any special arrangements or support that need to be made for your child. We will make sure that all records about your child are passed on as soon as possible. Where possible, we make arrangements for staff who have worked with your child to meet the new staff.</p> <p><u>When moving classes in school:</u></p> <ul style="list-style-type: none"> • Information, including learning targets, will be passed on to the new class teacher in advance • For children with EHCP and more complex needs, there will be a planning meeting and / or specific preparation or training for the new teacher and / or support staff • If your child would be helped by a transition booklet or social stories to support them understand 'moving on' then it will be made for/with them • Children create a piece of work all about themselves to present to their new teacher or school • Where understanding might be difficult, your child will visit their new school and in some cases staff from the new school will visit your child in this school <p>Depending on your child's Special Educational Need, it may be necessary to have a longer transition period than other children. We help children to think about their future and encourage them to reflect on their ambitions, which could include higher education, employment, independent living and participation in society. This is a natural part of the One Planning process for all adults involved and the child to look at aspirations for the future. 	
<p>How can I let the school know I am concerned about my child's progress in school?</p>	<ul style="list-style-type: none"> • If you have concerns about your child's progress you should speak to your child's class teacher initially. • If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the SENCO/Head Teacher. • If you are still not happy you can speak to the school SEN Governor. 	<p>All parents and their children</p>
<p>How will the school let me know if they have any concerns about my child's learning in school?</p>	<p>When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENCO. Our school also has pupil progress meetings every term between each class teacher and the Head Teacher, to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as expected. We use Target Tracker as a way of measuring progress.</p> <ul style="list-style-type: none"> • If your child is then identified as not making sufficient progress, the school will make a decision about whether to monitor this or set up an intervention group and will inform you. • If your child is still not making expected progress, we will discuss with you: • Any concerns you/we may have • Any further interventions or referrals to outside professionals to support your child's learning • How we could work together, to support your child at home/school. 	<p>All parents and their children</p>

<p>How is extra support allocated to children and how do they move between the different levels of SEN Support?</p>	<p>The school budget, received from Essex LA, includes money for supporting children with SEND.</p> <p>The Head Teacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of the needs of the children currently in the school.</p> <p>The Headteacher/SENCO discuss all the information they have about SEN in the school, including:</p> <ul style="list-style-type: none"> ○ the children getting extra support already ○ the children needing extra support ○ the children who have been identified as not making as much progress as would be expected. ○ deciding what resources/training and support is needed. <p>All resources/training and support are reviewed regularly and changes made as needed. Under the SEN Code of Practice all children on the register are termed to be in receipt of SEN Support. All children requiring SEN Support are closely monitored. They will have a One Plan. In time, children needing support from Specialist Services will have a 'One Planning' meeting to discuss your child's needs with any professionals working with them. At these meetings targets are suggested and plans and strategies put in place to achieve those targets.</p> <p>If your child is still not making the necessary progress, then we may consider that an EHC Plan might be needed and will send in a Request for a Needs Assessment Form to the Local Authority for them to consider this.</p>	<p>All children with SEN</p>
<p>How does the school involve other bodies, including Health and Social Care bodies, local authority support services and voluntary sector organisations, in meeting children and young people's SEN and supporting their families?</p>	<p>When a parent or member of the school staff have a concern regarding a child, we seek to obtain support for the child and their family from the most appropriate body. A referral will be made to the appropriate organisation that sets out the nature of the difficulties. A member of the school staff, usually the SENCO, will meet with the specialist and their families if requested. A plan of action will be implemented to best support the child. This will be shared with anyone working with the child including the teacher, LWSA and other school staff to ensure that all adults are following the agreed strategies.</p>	<p>All Children</p>

	<p>Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with an SEN.</p> <p>Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g. from the SEND Inclusion and Psychology Team.</p> <p>Training takes place on a regular basis. If you would like to hear about the training which is currently taking place or has taken place by the staff members in the school, please speak to the Headteacher.</p> <p>If we are unsure how best to support a child, we seek the guidance of the Inclusion Partner or Educational Psychologist who may come in to work with school staff to provide information, strategies and guidance in how to support particular children. It may be that we attend a drop in with the specialist teachers for the same support.</p>	
<p>How will the teaching be adapted for my child with Special Educational learning needs?</p>	<p>Class Teachers plan lessons according to the specific needs of all groups of children in their class and will ensure that learning tasks are adjusted in order to enable your child to learn as independently as possible.</p> <p>Specially trained support staff can implement the teachers modified/adapted planning to support the needs of your child where necessary.</p> <p>Specific resources and strategies may be used to support your child individually and in groups - access plan including disabled toilets, behaviour charts/rewards, visual timetables, left-handed scissors, writing slope, Finger Gym & Gym Trail resources, wide range of reading materials, Interactive Whiteboards, social stories.</p> <p>Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs and increase your child's access to what is on offer. How does the school measure children's progress in school?
How will parents know about this?
Will parents be involved in the assessment and review process?

Your child's progress is continually monitored by his/her class teacher.

His/her progress is reviewed formally every term and a National Curriculum/Engagement Model / EYFS level in reading, writing and maths is entered into Insight for monitoring. Progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour are also considered.

If your child is in Year 1 and above, but is not yet at National Curriculum levels, a more sensitive assessment tool is used which shows their level in more detail and will also show smaller but significant steps of progress. Years 2 and 6 will be assessed against the Pre-Key Stage Standards.

Children working between P1 and P4 will be assessed using the new Engagement Model (July 2020).

At the end of Key Stage 1 and Key Stage 2, (i.e. at the end of Year 2 and Year 6), all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requests all schools to do and the results are published nationally.

The SENCO's role is to support class teachers in planning and implementing appropriate provision for pupils with Special Educational Needs (SEN). She offers guidance to ensure the right support is in place and will make referrals to external services when necessary.

For pupils receiving SEN support, One Plans will be jointly written by the SENCO and the class teacher. However, the class teacher will be responsible for leading the termly One Plan meetings with parents and carers, as they have the most regular contact with the child and oversee day-to-day provision.

The progress of any children with an EHC Plan, is formally reviewed at an Annual Review with all adults involved with the child's education.

SENCO will also check that your child is making good progress within any individual work and in any group that they take part in.

	<p>A range of ways will be used to keep you informed, which may include: Parent consultations, review meetings, Annual Review Meetings, additional meetings as required, reports, rewards and celebrations.</p> <p>We aim to involve parents as fully as we can in the progress their children make and the targets that are set. We believe that when we work together, children make far greater progress.</p> <p>When a child with SEN begins an intervention then assessments are made prior to starting. At the end of an intervention further assessments are made to ensure your child has made adequate progress. If an intervention is clearly not having an impact, then another will be put in place.</p> <p>St Mary's C of E Primary School ensure they do all they can to measure the impact of the provisions we put in place. If something is not working, we will find an alternative that will.</p>	
<p>What support does the school offer to the parents/carers of children with SEN/and or disabilities?</p>	<p>Ms Walker and your child's class teacher is available to meet with you to discuss your child's progress or any concerns/ worries you may have.</p> <p>We would like you to talk to your child's class teacher, (or LSWA), regularly so we know what children are doing at home and we can tell you about what we are doing in school. This is to ensure that we are doing similar things to support them both at home and school and can share what is working in both places. If you wish to see the class teacher, you can book an appointment after school.</p> <p>All information from outside professionals will be discussed with you by the person involved directly, or where this is not possible, in a report. The SENCO is available to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child and will always seek your involvement in matters of concern.</p> <p>You will have an extra opportunity each term to discuss your children's learning targets and progress with the teacher/SENCO.</p>	<p>All parents/carers of children with SEND.</p>
